# **DERREL SIMMS**

- Derrell Sims' work is the study of alleged "alien implants" (foreign anomalous objects in the human body reported to have been installed by an alien being). A few of the individuals who claim to have had such alien contact and who apply to have their objects removed are instructed to provide sufficient information. Their cases are reviewed by Sims and his professionals to determine if the applicant(s) should be accepted as candidates for the surgical procedure(s). If appropriate, the object may be removed. Arrangements are orchestrated by Sims and performed by surgeons and medical professionals in his presence.
- Not all foreign objects recovered pass the tests Sims uses to scrutinize whether the object(s) could actually qualify to be potential alien implants. Such implants comprise a portion of Sims' collection of evidence obtained over the course of decades. Simms claims to have in his possession the largest private collection of physical evidence of alien/human contact including skin samples, DNA samples, XRays/MRIs, sonograms, objects with possible forensic traces (on glass, on walls, etc.), anomalous implants/artifacts expelled from the human body and those surgically removed. He is the first UFO

### **BOOK REVIEW**

### HOW TO DEFEND YOURSELF AGAINST ALIEN ABDUCTION

UFO researcher and author Ann Druffel dates her interest in the UFO question from her first sighting in 1945. She was one of the first investigators for NICAP, remaining with that organization from April 1957 to 1973. Then, she joined the Mutual UFO Network (MUFON) and became an investigator. She also joined the Center for UFO Studies (CUFOS) and contributed articles on California sightings and other UFO subjects to IUR (International UFO Reporter). She was a U. S. consultant and regular contributor for the British research journal FLYING SAUCER REVIEW (FSR) through 2004. She authored six books and many articles for MUFON and newsstand magazines on UFOs and other earth mysteries. She co-authored The Tujunga Canyon Contacts and was a contributor to the Encyclopedia of UFOs, and a frequent speaker on the UFO/UAP circuit and an expert on TV and radio. She was one of Southern California's best-known ufologists. She devoted her life to UFO research and passed away June 12, 2020.

This book presents many true accounts drawn from a database of 120 "resisters," which demonstrate how nine simple mental and physical techniques can drive away alien abductions. It proposes that these beings may exist at any level of reality and are "posing" as occupants of physical UFOs. It was written for all members of the American public who are interested in various aspects of the UFO question.

Druffel has yet to decide what she believes. Most abduction scenarios take place in altered states of consciousness, so she doubts the physical reality of so-called genetic manipulation, missing fetuses, alien-military cooperation, and "alien implants" associated with abduction scenarios due to the lack of solid scientific proof. However, she agrees that many abduction scenarios may be real in some type of "altered reality," especially those reported by undeniably rational, honest, and productive individuals. The book compares Celtic and Muslim paraphysical beings with alien abductors and suggests that they may be one and the same. I am not convinced.

This book provides food for thought. When reviewing the nine mental and physical techniques to stop alien abductions, it was apparent that the one common denominator is believing in whatever technique you choose. They are all similar. The readers need to choose what fits them best. If you are being harassed by non-human beings and you want it to stop, then this book may provide you with needed information. If not, you may

still find the encounters interesting. On a scale of 1-5, I rate this book at 3.00.

# **REPORTED IN THE ANOMALIST**

**The All-domain Anomaly Resolution Office (AARO)** finally has a new chief. Dr. Jon T. Kosloski brings an impressive background to AARO, but his attitudes towards the UFO subject and indeed his knowledge in that area are uncertain. Some knowledgeable commentators hope for greater transparency from the Office, while Kevin Randle says, "It's more of the same." John Greenewald's experience shows AARO has far to go. A FOIA response for details on "their classified web portal for their UFO research office" basically got John "two images ... of very low quality, with much of the text unreadable." Even the unclassified text of what he sought was withheld. Also, "After years of bureaucratic obstacles and inconsistent responses," John did acquire new evidence perhaps supporting former AATIP figure Luis Elizondo's retribution and cover-up claims against the Government. At the very least the documentation indicates weaknesses in governmental FOIA performance that may challenge new AARO Director Kosloski's DoD-emphasized responsibilities "to research and explain unidentified anomalous phenomena to...the American people." Kosloski's getting a strong message from UFO-transparency firebrand Representative Tim Burchett, regarding UAP data sources: "Turn 'em loose." And Burchett emphasizes this is a bipartisan, bicameral (Senate and House) priority.

A Senate Armed Services Committee Subcommittee on Emerging Threats and Capabilities

**hearing** "will likely take place after the Nov. 5 election," according to Subcommittee Chair Kirsten Gillibrand. Subcommittee member and former astronaut Mark Kelly made some measured and supporting comments on the need to investigate reports from our military personnel. Mark doesn't scoff like his brother and also former NASA astronaut Scott did when Scott was on NASA's Independent Study Team on Unidentified Aerial Phenomena.

Luis Elizondo's new best-selling book "Imminent: Inside the Pentagon's Hunt for UFOs" gets great praise from Billy Cox. Keith Basterfield recommends it both to the relatively unversed in the subject matter and "those who have long studied the topic." French ufologist Baptiste Friscourt lauds it. I found Imminent read very smoothly, had some surprises, and gave an explanation of AAWSAP/AATIP that made more sense of that whole mess than I've received so far. Its marshaling of all the details together in one work helped me evaluate how each may have interrelated in what is perhaps the most complicated of recent UFO stories. I observed in last month's Colorado MUFON Newsletter report that many commentators don't consider the "target audience" for a "best-seller candidate." And the same for Jason Colavito's negative comments on Lue's recent appearance on Ronny Chieng's "The Daily Show." Given that TV program's comedic format, I think Elizondo (and host Chieng) aired most of Lue's primary talking points. Based upon an informed legislature, Congressional action has immediate primacy towards answering what important Congresspeople on both sides of the aisle justly feel is an important matter. I also disagree with Miguel ("Red Pill Junkie") Romero's judgment that Elizondo, Christopher Mellon, and their allies' overall strategy is "absurd." For decades, almost nothing advanced UFO respectability and dislodged some Government admissions (and legislation) until Elizondo, former Senate Majority Leader Harry Reid's previous initiatives, and Government Insider Mellon combined in late 2017 To Do Something About It. Pressure must be maintained upon and within Congress, lest Kevin Randle's justified fear of history repeating itself is confirmed.

**Another huge ufological headline** is "Another UFO Boss to Break Silence in Major Book Deal: "The Process of Disclosure Has Begun." Following upon Luis Elizondo's *Imminent* publication, former UAPTF director Jay Stratton has signed up with publishing house HarperCollins, no less. The Stratton book project was developed with Farah Films producer Dan Farah. Farah previously backed Luis Elizondo's best-seller. If you wonder what may be next, we learn that Farah "also has TV and film rights" to Stratton's memoir.

**Other Government News:** The National Archives and Records Administration (NARA)'s Unidentified Anomalous Phenomena Records Collection (UAPRC) has posted about zilch worthwhile so far from its charge to consolidate all "government-funded records relating to unidentified anomalous phenomena, technologies of unknown origin, and non-human intelligence." That per Billy Cox and my boss Patrick Huyghe, who notes "We are just a month away from the notification deadline when the federal agencies are required to comply with the law" to at least collect the records. Donald Trump's ex-National Security Adviser Raymond McMaster does allow "there are phenomena that have been witnessed by multiple people that are just inexplicable by any kind of science available to us." And former top advisor to Presidents Kennedy, Johnson, Nixon and Ford Harald Malmgren says a CIA official briefed him on "otherworld technologies" in the 1960s.

Fishermen discovered a classified Defense Advanced Research Projects Agency's (DARPA)

drone floating near Hawaii, generating thought about "transmedium vehicle" development. Liberation Times' Kyle Warfel and Christopher Sharp made a troubling FOIA-assisted report on the December 2023 incursions over Langley AFB in Virginia, and emphasize how serious are the safety and defensive "gaps" such events illustrate. A very interesting 10-month multi-instrumented study of aerial phenomena off of the "Jersey Shores" was conducted by engineers Gerald and John Tedesco. Micah Hanks reports some patterns in his UAP Sightings Reporting System (UAPSRS) that was officially launched in January, and constructed to requirements specified by that NASA study team last year. Kevin Randle had to prove again that the debris shown in those posed 1947 office photographs was not what Jesse Marcel, Sr. and Sheridan Cavitt had found at the Roswell crash site. And Kevin and researcher David Rudiak found there were three claimed Kingman, Arizona, area flying saucer crashes/landings in early 1953, and possibly one three years earlier. Some academic and other mainstream-anchored groups are leveraging the Social Sciences towards grasping the totality of the UFO-Human connection. There is bitter counterattacking from others, claiming the "surging" belief in ET visitors is a serious problem. But talk about mainstream acceptance of the possibility: Hidden Forces' Demetri Kofinas interviewed "global macro investor David Dorr" on "How Investors Should Think About UAP Risk"!

**Deaths:** Another ufological lion is gone. Robert M. Wood is dead, at the age of 96. A truly remarkable person, "Dr. Bob" had an amazing professional career and was a prominent force in and contributor to the ufological world for six decades. James Earl Jones, one of the greatest dramatic actors, has also died. His performance in the 1975 movie about the Barney and Betty Hill abduction and its sequelae remains truly memorable.

**Fun, Miscellaneous, and/or Downright Weird:** A recent outbreak of "UFOs" over Tampa turned out to be "AI generated UFO videos" to promote an upcoming Halloween party. And a Mexican tire show owner filmed a UFO (probably a balloon) and made a commercial about it that got over six million views and counting!





# Field Investigator's corner **CASE 137604**

#### From Form 1:

During the summer of 2014, the witness was stationed at F.E. Warren Air Force Base in Cheyenne, Wyoming. Their primary role was nuclear security. One night, a non-nuclear explosion occurred at one of the nuclear sites, causing all the site alarms to fail. As a result, the witness, along with another team member, was dispatched to provide physical security.

At approximately 1 or 2 in the morning, they noticed what initially appeared to be a star growing brighter. After a few minutes, it became clear that this was not a growing star, but some sort of craft. The object was a bright, spherical shape, glowing white. Due to the lack of reference points, they were unable to estimate its distance.

After observing the stationary object for several minutes, they retrieved night vision goggles and binoculars from the vehicle to get a better view. For nearly 20 minutes, the glowing sphere remained motionless in the sky before it started to move. It began traveling in very precise straight lines, covering a few clicks before abruptly changing direction without losing speed, maintaining a straight trajectory. The object repeated these maneuvers several times over the next hour before accelerating rapidly across the Nebraska sky and disappearing out of sight within seconds. To this day, there is no explanation for what was observed that night. The story has only been shared with close friends and family in hopes that someone might help provide clarity on the experience.

#### **Summary of Field Investigator Notes:**

It would have been helpful to have the exact date of the UFO sighting, as it would allow for a more detailed analysis of other relevant data such as astronomical events, weather patterns, satellite activity, and air traffic records. The witness, however, could not recall the specific date and mentioned needing to find his discharge papers to confirm it. He noted that the sighting occurred roughly ten years ago and acknowledged difficulty remembering certain details from that period. This memory lapse could potentially indicate some form of psychological impact from the incident, such as "missing time," which has been associated with some UFO encounters. The witness described a sense of heightened wonder and excitement following the sighting, as well as a perception that the remainder of the night seemed to pass unusually quickly.

It would have been beneficial to interview the witness's colleague, who was present during the sighting, but he has not yet agreed to speak with us. The witness did mention that he recently reconnected with this individual and had multiple conversations about the incident, informing him that we were interested in speaking and that his anonymity would be protected. We have not pursued information on other daytime Air Force security personnel, as their accounts would likely not contribute significantly to the UFO report itself but could provide context regarding the missile site and potential silo damage.

From the witness's description, the object's movements could not be attributed to meteors, satellites, drones, or any conventional aircraft. He detailed the object performing precise "L-shaped" maneuvers, changing direction without pausing, and exhibiting rapid acceleration and speed-characteristics that are inconsistent with known military or civilian technology. These details strongly suggest that the object was some type of unidentified aerial vehicle (UAV) rather than a terrestrial aircraft.

When determining the case disposition for this sighting, I consulted with SD/Colorado. We discussed how a purely luminous object could have "structure." He posed the question of whether the light/object seemed to exhibit any form of consciousness or intelligence in its movement. I agreed that it appeared to be under deliberate control, as the witness believed it was actively surveilling the area. Based on these factors, we concluded that the sighting falls under the classification of an Unknown/UAV
